About SRM Medical College

The SRM Educational institutions were established in 1969. It has steadily grown into the prestigiousSRM Institute of Science & Technology (SRM IST). Today, it is a 'deemed to be' university, covering all the branches of knowledge. About National Institute for Empowerment of Persons with Multiple Disabilities (NIEPMD)

Established in 2005, on East Coast Road, Muttukadu, Chennai, Tamil Nadu, under Department of Disability Affairs, Ministry of Social Justice & Empowerment, Govt. of India, to serve as a national resource centre for empowerment of persons with Multiple Disabilities such as those with two or more disabilities in a person. It serves over three dozens of different categories of Multiple Disabilities across the country.

Services for persons with multiple disabilities has been given through a multi-disciplinary team model, besides the cottage and extension services. With the support of eight departments, this institute aims to achieve the following objectives: to undertake development of human resource management, training, rehabilitation, education, employment and conduct research in all areas pertaining to multiple disabilities. Also, it extends strategic social rehabilitation services to meet the needs of diverse groups of people with multiple disabilities and their families.

About the workshop

The RPwD Act of 2016 replaces the PwD Act of 1995. In the new act, the number of disability types have increased from seven to twenty one. As a consequence, the percentage of disabled persons would increase by three to five percent. To meet this increase, the higher learning institutions will have to turn out an increased number of professionals. Additionally, the skill sets of existing man power will have to be updated. Recent advances in medicine and in technology, enable the disabled persons to function independently as par with others. These advancements must be adopted and more ambitious strategies have to be developed.

Globally, several efforts are taken in this noble direction. The Government of India is also keen to develop a framework to rehabilitate them. So far, five major legislations have been enacted, with the aim of inclusion of PwDs into the main stream society. Around 100 projects and programmes have been implemented in the government sector. Several voluntary organisations are doing their mite. However, the benefits still lack

a wide reach. The main reason appears to be a lack of awareness about the rights of PwD, among the PwDs themselves and among the general society. Many rehabilitation professionals, also, are in the dark about these issues. This lacunae have to be bridged. This conference would serve to disseminate practical information to all the concerned professionals. On returning to their respective stations, the participants should be able to implement what they have learnt during the workshop. This workshop, thus, will have a cascade effect.
