# LIEUTENANT COMMANDER GOPU SUNDARARAJAN

Lieutenant Commander Gopu Sundararajan, Director, Apollo Aerospace Components Pvt Ltd for India and Rest of India region. Sir completed his schooling in Bengaluru from St Joseph's Boys High school in 1993. He went on to do his Electrical and Electronics Engineering from MS Ramaiah Institute of Technologies Bangalore with Honors and Distinction.

During the final year, he was selected by the Ministry of Defence, Service Selection Board under merit to join the Indian Navy and was Commissioned into the Indian Navy Aviation branch as a sub lieutenant by the President of India. He is the 1690th Electrical officer to be commissioned into the Indian Navy since its inception.

As a Sub Lieutenant he was selected by the Integrated Headquarters Ministry of Defence in Navy to do his Masters in Aeronautical from Naval Institute of Aeronautical Technology Cochin in collaboration with Cochin University of Science and Technology.

During his service with the Indian Navy he participated in various operations one amongst which was the Ops Parakram in 2002 which was the second biggest military standoff between India and Pakistan after Kargil and he was also awarded the commendation by the Commander in Chief Eastern Naval Command for his contribution and dedication to duty beyond the normal call and ensuring operational readiness of the Anti-submarine warfare aircraft.

He retired from active service as a Lieutenant Commander in 2007 and was placed in the emergency reserve list until 2012. His second innings into the corporate world started with a French Major Capgemini as a Program manager where he was the leader for 3 verticals Aerospace and Defence, Hi Tech and Life sciences. He then Joined TATA group to work with a core team to set up the TATA Aerospace and Defence manufacturing facilities in Hyderabad. After 5 years with the TATA group he moved to become the Business head for a Bangalore based business house Maini Aerospace and spearheaded their marketing and operations to grow their Aerospace and Defence business.

He is now the Director of Apollo Aerospace Components for India and the rest of Asia for the past 7 years and is providing products and services to the Indian Aerospace and Defence Industry.
