1. ONLINE VERIFICATION (SRM Website):

4. FOR OFFLINE VERIFICATION:

For Universities, Colleges, agencies etc., who wants to verify the certificates issued by SRMIST, following are the procedure to be followed:

- Forward a Photocopy of Transcript, Degree certificate, Provisional certificate, Migration certificate etc. issued by the Office of the Controller of Examinations for which verification needs to be done.
- Prescribed fee (non-refundable): **Rs.500.00** (Rupees Five Hundred only).
- The mode of payment can be paid directly into the bank account – IOB, Secretariat (1172) under the Head **SRMIST Certificate Verification Fee – A/c No.117201000018176, IFSC code is IOBA0001172** or by means of Demand Draft (DD) in favour of “**SRMIST Examinations**” payable at **Chennai**.
- The copy of the receipt / DD should be forwarded along with communication letter to the Office of Controller of Examinations, either by e-mail (cv.coe@srmist.edu.in) or by post
- Normal processing time duration towards verification of certificates is **FIVE** working days.
