WHEREAS, the recognition was granted to the institution namely, SRM Institute of Science & Technology (Deemed University), Chennai, Tamilnadu-600033 for B.Ed., & B.Ed.-Al programme as per following details:-

- The SRC vide order No. F.TN/SEC/SRO/SRO/NCTE/2005-2006/4042 dated 17.11.2005 for conducting Secondary (B.Ed.) course of one-year duration with an annual intake of 100 students from the academic session 2004-2005.
- (ii) The SRC vide order No. F.SRC/NCTE/2009/B.Ed-Al/RO/12777 dated 15.05.2009 for conducting B.Ed.-Al programme of one-year duration with an annual intake of 200 (Two Hundred) students which includes the existing intake of 100 (one Hundred) students from the academic session 2009-2010.
- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit on 20.06.2015 for its willingness of two units in B.Ed. & B.Ed.-Al course and adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 02.07.2015 & 23.03.2015 for conducting B.Ed. & B.Ed.-Al Programme of two years duration with an annual intake of 100 (two basic units) & 100 (two basic units) from the academic session 2015-16.
- AND WHEREAS the SRC in its 369th Meeting held on 28.01.2019 considered the 3. matter and decided to issue SCN in all such matters where the institution has not submitted requisite documents/VT report accompanied with requisite documents in responds to RPRO issued by the SRC. Accordingly, as per decision of SRC a Show Cause Notice was issued to the institution on 26.03.2019. The institution has submitted reply on 10.04.2019.
- AND WHEREAS, the SRC in its 379th Meeting held on 21st & 22nd August 2020 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per decision of SRC a Final Show Notice was issued to the institution on 29.08.2019. The institution has submitted reply on 19.09.2019.
- AND WHEREAS, the SRC in its 408th Meeting held on 02nd March, 2022 considered the request from 4 units to 1 unit matter and decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee agreed to reduce the intake of the institution as per its request vide letter dated 31.12.2021 from 4 Units to 1 unit.

The Committee on the perusal of the reply submitted by the institution and request made by the Registrar of the University for retaining only one unit in B.Ed. programme, decided that the continuation order be issued to the Institution SRM Institute of Science & Technology (Deemed University), Research No. 54, Potheri Village, Kattankulathur, Chengalpattu Taluk, Chennai, Tamilnadu-603203 for B.Ed. programme for 1 basic unit of 50 students."

- 6. **NOW THEREFORE**, by withdrawing 3 units of B.Ed. Programme w.e.f. from the academic session 2022-2023 the institution i.e., **SRM Institute of Science & Technology (Deemed University)**, Research No. 54, Potheri Village, Kattankulathur, Chengalpattu Taluk, Chennai, Tamilnadu-603203 run by M/s Valliammai Society, Research No. 54, Potheri Village, Kattankulathur, Chengalpattu Taluk, Chennai, Tamilnadu-603203 is permitted for continuation of **B.Ed. programme** for two years duration with an annual intake of **1 basic unit of 50 students** subject to fulfilment of the following conditions: -
 - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 7. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 8. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 9. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
 - a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left of joined during the last, quarter:

- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
- e. Fee charged from students.
- f. Available infrastructural facilities.
- g. Facilities added during the last quarter.
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- i. The affidavit with enclosure submitted along with application.
- i. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 10. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 11. The institution shall make available the list of students admitted on its official website.
- 12. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
