

APPLICATION FOR RECOGNITION AS Ph.D. SUPERVISOR**Norms for Supervisor Recognition**

Recognition of supervisor for guiding research work will be accorded by the Vice Chancellor, on application to the Director (Research) through proper channel in the prescribed format with the recommendation of a subject expert identified by the Director of the concerned faculty.

Only a full time regular teacher of the concerned University can act as a supervisor.

- (i) Any Professor/Associate Professor of SRMIST with a Ph.D., and at least five research publications in peer-reviewed or refereed journals and Assistant Professors in SRMIST with a Ph.D., and at least three research publications in peer-reviewed or refereed journals during the preceding 5 years may be recognized as a Research Supervisor at SRMIST. Such recognized research supervisors cannot supervise research scholars in other institutions, where they can only act as co-supervisors. Ph.D. awarded by another University under the supervision of a faculty member who is an employee of SRMIST or its affiliated Postgraduate Colleges/institutes would be in violation of these Regulations.

A minimum of two years of research or teaching experience after acquiring Ph.D. degree is essential for getting recognition as a Ph.D. supervisor. However, exemptions based on merit shall be considered and approved by the Vice-Chancellor.

- (ii) A research supervisor without Ph.D. qualification in Medical Sciences should have not less than 15 years of teaching and research experience after obtaining his/her Post Graduate qualification and shall also have not less than 10 years of Post Graduate teaching experience as a faculty member with a minimum of two publications in the relevant or allied areas of research in indexed journals with SNIP/IF>1 in the last 3 years For Ph.D. scholars working in Central government/ State government research institution.
